### • Leasing Preserves Bank Lines

Bank lines are designed for short term needs and should be preserved for that purpose. Leasing is like opening an additional and separate line of credit, expanding, as opposed to restricting, your financial resources. Leases do not require substantial down payments or compensating balances, do not have floating interest rates or restrictive covenants, and can usually be structured with lower monthly payments.

### • Leasing Hedges Against Rapid Obsolescence

Leasing facilitates equipment upgrades since there are usually no penalties for the actual upgrade and because a large portion of the investment in the old equipment has already been written off.
